- * By signing this agreement, you are acting on behalf of the hire club/organisation and are waiving your rights to sue Benalla Equestrian Centre Inc. for any responsibility or liability for accidents, damage, loss, injury, permanent disability or death to humans or horse/s - as a result of hiring the Venue, 5809 Midland Highway, Benalla.
- * This agreement includes participants and members of the club/organisation hiring the venue, your horse(s) intended on being ridden during the activity, spectators and other persons assisting or attending the facility with your club/organisation.
- * Benalla Equestrian Centre Inc. accepts no liability for accidents related to horse transport, movement and horse riding. You transport, handle saddle, participate with and ride Your horse at Your own risk.
- * The club/organisation understand and acknowledge that horse riding is a dangerous activity and that horses can act in a sudden and unpredictable way, especially if frightened or hurt, which notwithstanding the best endeavours, skill, care and diligence of the rider, handler and guide or instructor creates an unavoidable risk or physical harm.
- * The club/organisation understand and acknowledge that horse riding is an inherently dangerous activity that carries a significant risk of serious injury. The club/organisation understand that wearing an approved equestrian safety helmet substantially reduces the risk of head injury. They acknowledge that The Benalla Equestrian Centre Inc. recommends and requires the wearing of approved safety helmets. If they choose not to wear a helmet, they do so voluntarily and accept the increased risks associated with that decision.
- * We have read and understood the above terms and conditions. We agree to abide by these conditions. We understand failure to comply with these rules may result in refusal for future hiring of the venue.
- * Any accidents, hazards, risks or damage to the venue must be reported immediately to Raise the Roof Benalla Inc.
- * We have been given an induction and tour of the facilities. We are aware of parking, yards, toilets, hosing/water, venue entry/exit, and the equipment for cleaning up and disposing of manure/feed waste
